The Trusts Workbook is provided to delegates who attend the TIA's annual National Trusts Roadshow series, which is presented by Harwood Andrews Lawyers.

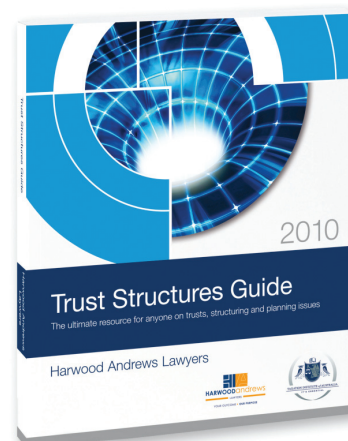
National taxation journals - Taxation in Australia & Tax Specialist
